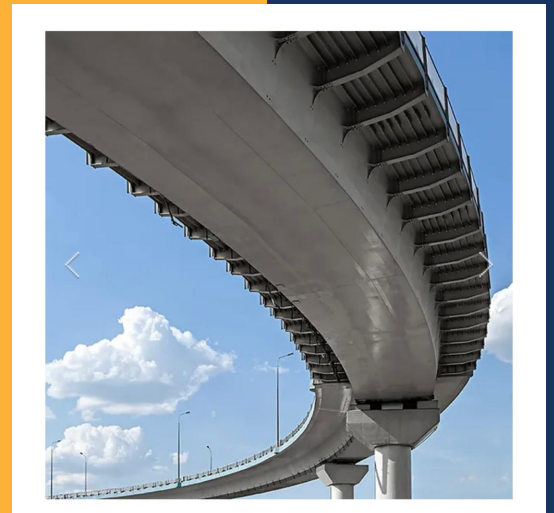
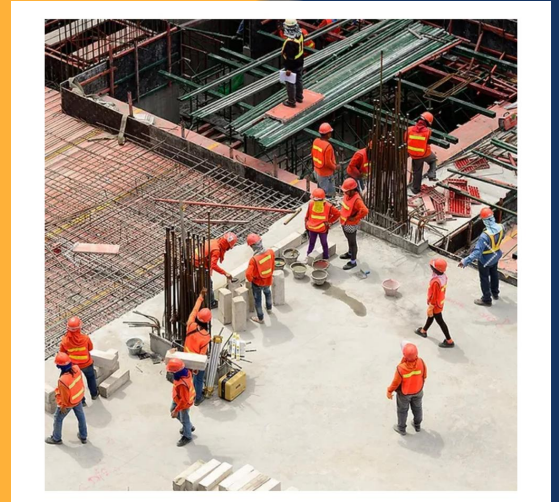
We are pleased to present our company to you in order to give brief idea about the history of our company, the company was established on 1998 in order to operate business of general trading and contracting.
